

The 148th International Training Course
“Drug Offender Treatment: New Approaches to an Old Problem”

1. Duration and Participants

- From 11 May to 17 June, 2011
- Ten overseas participants (including two observers) from seven countries
- Eight Japanese participants

2. Programme Overview

Treating offenders with drug dependency has long been a serious challenge for criminal justice systems, in developed and developing countries alike; such offenders are numerous and have a relatively high recidivism rate when treated under traditional interventions.

This programme addressed this long-standing issue from two perspectives: (1) effective interventions for drug-dependent offenders; and (2) the effective criminal justice response to drug-dependent offenders, and offered the participants an opportunity to share experiences and expertise and to examine measures regarding effective treatment of drug-dependent offenders.

Major topics for discussion included:

- Current situation of treatment of drug-dependent offenders (statistical description; an overview of the currently available treatment measures and their challenges; and the pharmacological, pathological and psychological impact of illicit drugs on human beings).
- Effective interventions for drug-dependent offenders (assessment of recidivism; formulating treatment plans; psychological and psychiatric interventions; and evaluation of interventions' effectiveness).
- Effective criminal justice response to drug offenders (diversion programmes; drug addicts' rehabilitation facilities; drug courts; partnership with non-governmental organizations; and costs and benefits concerning interventions to reduce recidivism).
