

**The 145th International Training Course**  
**“Effective Resettlement of Offenders**  
**by Strengthening ‘Community Reintegration Factors’”**

**1. Duration and Participants**

- From 12 May to 18 June, 2010
- Twelve overseas participants from nine countries/territories (incl. two observers)
- Eight domestic participants

**2. Programme Overview**

In order to effectively prevent recidivism, measures aimed at strengthening “community reintegration factors” of offenders, such as stable accommodation, basic skills (*e.g.*, literacy and numeracy) and secure employment, are essential.

This Course was designed to provide the participants with an opportunity to examine the current situation, identify difficulties, and explore possible measures regarding strategies for strengthening those reintegration factors.

Major topics for discussion included:

- Strengthening community reintegration factors during investigation, prosecution and diversion at the pre-adjudication stages;
- Consideration of community reintegration factors in sentencing;
- Strengthening community reintegration factors during institutional and community based treatment:
  - Employment support;
  - Academic/educational training;
  - Developing other basic skills;
  - Securing accommodation after release;
- Establishing co-operation between the public and the private sectors and promoting ‘community involvement’.
