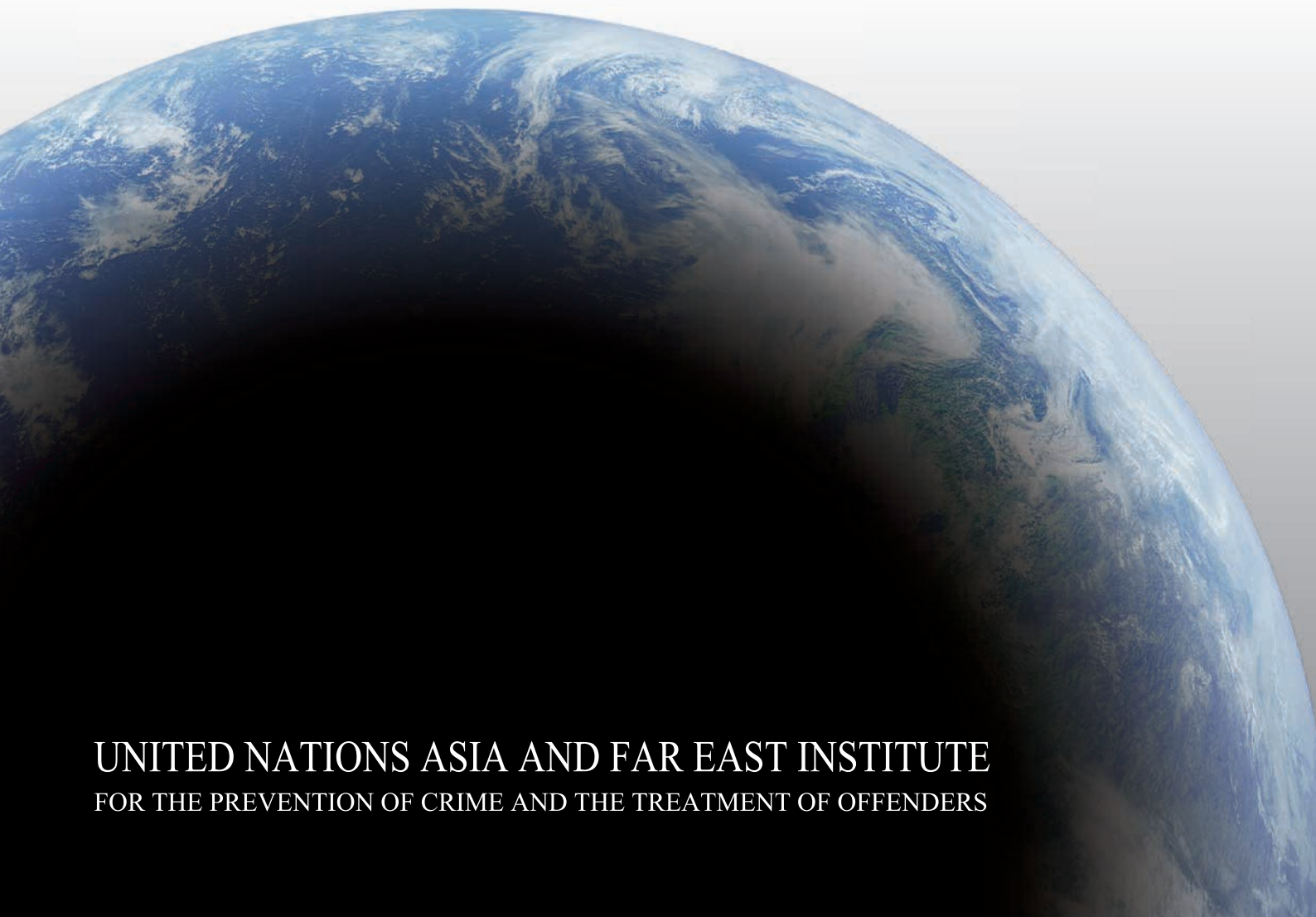

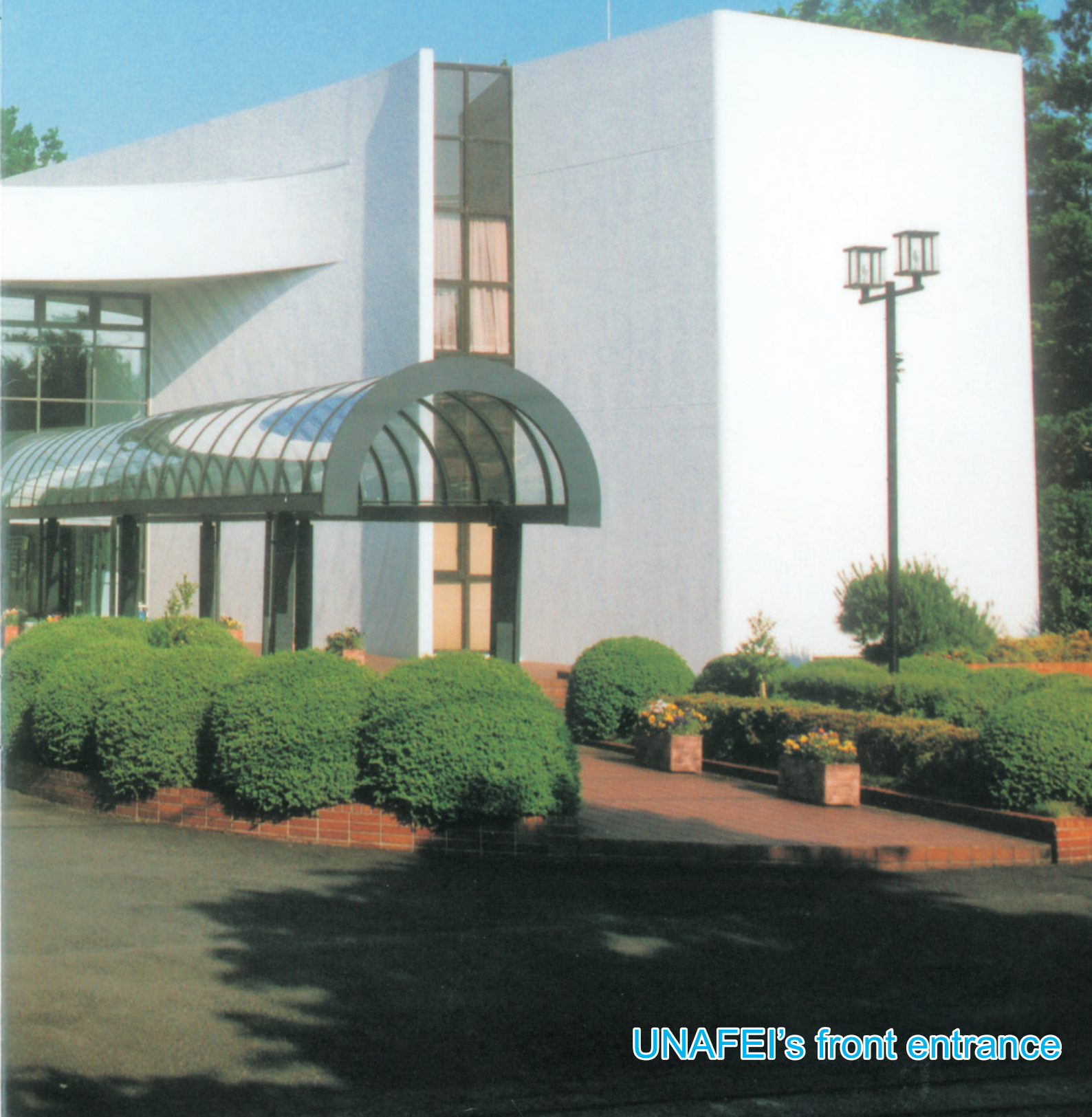

# UNAFEI contributes to the enhancement of justice in the international community

The United Nations Asia and Far East Institute for the Prevention of Crime and the Treatment of Offenders (UNAFEI) is a United Nations regional institute, established in 1962 by agreement between the United Nations and the Government of Japan. UNAFEI's main activities are to hold international training courses and seminars for criminal justice personnel from around the world and to conduct studies and research in the field of crime prevention and offender treatment. Following the United Nations policies and efforts concerning criminal justice, UNAFEI contributes to promoting the sound development of criminal justice systems and mutual cooperation among UN member states, especially developing countries in the Asia and Pacific Region. UNAFEI's activities, fully funded by the Government of Japan, are highly valued as part of Japan's contributions to the international community.

UNAFEI is operated under the joint auspices of the Government of Japan and the United Nations, based on a written agreement between these two governing bodies. The United Nations Training Cooperation Department in the Research and Training Institute of the Ministry of Justice, assuming full responsibility for financing and personnel, conducts training courses, surveys, and research in cooperation with the United Nations. The Director of the department serves as the Director of UNAFEI, in consultation with the United Nations. Professors, who are selected from among judges, public prosecutors, and correctional and probation officers, and the secretariat undertake the programming and implementation of UNAFEI's activities in cooperation with related organizations, such as the Japan International Cooperation Agency (JICA) and the Asia Crime Prevention Foundation (ACPF).

UNAFEI is the oldest of the United Nations regional institutes located around the world (Africa, Latin America, Northern Europe, etc.). UNAFEI contributes to the planning and implementation of United Nations policies concerning worldwide crime prevention and offender treatment, keeping close contact with the United Nations Office on Drugs and Crime (UNODC) in Vienna and other United Nations Crime Prevention and Criminal Justice Programme Network Institutes (PNI).

## History

- Mar. 1954 The 1st United Nations Asia and Far East Convention for the Prevention of Crime and the Treatment of Offenders is held in Rangoon, Burma (now Yangon, Myanmar). A resolution is adopted calling for the establishment of a U.N. regional training institute in Asia.
- Mar. 1961 The U.N. and the Government of Japan sign an agreement establishing a United Nations regional training institute in Japan (March 15). Administrative and financial responsibilities are borne equally by the two.
- Mar. 1962 UNAFEI is inaugurated (March 15).
- Sep. 1962 The 1st International Training Course is conducted.
- Apr. 1970 The Government of Japan assumes all administrative and financial responsibilities following an amendment of the March 1961 agreement.
- Jan. 1982 The present UNAFEI building is completed.
- Mar. 1993 His Imperial Highness, The Crown Prince Naruhito, visits UNAFEI.
- Nov. 2001 UNAFEI Osaka office opens.
- Oct. 2002 UNAFEI celebrates its 40th anniversary.
- Dec. 2003 UNAFEI receives an award from the President of the National Personnel Authority.
- Aug. 2009 Her Royal Highness Princess Bajrakitiyabha of Thailand visits UNAFEI
- Dec. 2012 The Joint Ceremony for UNAFEI's 50th and ACPF's 30th Anniversaries.
- Jan. 2013 Her Royal Highness Princess Bajrakitiyabha visits UNAFEI
- Sep. 2015 The 25th Anniversary Seminar of the United Nations Standard Minimum Rules for Non-custodial Measures (The Tokyo Rules)

# Technical Assistance

## International training courses and senior seminars

Since the first international training course in 1962, UNAFEI has held two international training courses and one international senior seminar annually. In every course and seminar, a different theme focusing on important issues in our globalizing society is selected and discussed. As of 1 March 2017, UNAFEI has conducted a total of 165 international training courses and senior seminars.

The international training course held in spring mainly deals with crime prevention and countermeasures against various crimes, while the one held in autumn concentrates on the treatment of offenders. In recent years, the duration of the international training courses has varied from five to six weeks. Participants should be criminal justice officials holding relatively senior or high-ranking positions in their respective countries. Usually, about twenty overseas and five to ten Japanese participants take part in each course or seminar. The main components of the programmes are: presentations by participants on the current criminal situation and criminal justice issues in their countries; lectures by UNAFEI professors and experts from Japan and abroad; observation visits to criminal justice agencies; group workshops; and plenary discussions.

## Various types of technical assistance

Upon request from recipient countries around the world and the United Nations, UNAFEI provides various types of technical assistance in addition to international training courses and senior seminars. Such assistance mainly consists of training courses and seminars both at UNAFEI and overseas locations. While themes, numbers of participants (10 to 20 people) and duration (from a few days up to four weeks) vary, all technical assistance projects are important activities at UNAFEI.

Since 2000, UNAFEI has held an annual international training course entitled “The Criminal Justice Response to Corruption”. Course participants from various countries, including Japan, discuss the current situation of corruption in the participating countries, criminal justice responses and related issues, and the background and causes of corruption. In addition, they explore measures for establishing a more effective criminal justice system and debate specific measures to manage the system effectively. Every year, about 15 participants from overseas and five participants from Japan are invited.

Since 2013, UNAFEI has supported Nepal’s reform and improvement of its criminal justice system through conducting a series of programmes called the Joint Comparative Study on the Criminal Justice Systems of Japan and Nepal. Criminal justice officials from Nepal have learned about the Japanese criminal justice system by hearing lectures at UNAFEI, visiting several criminal justice agencies in Japan and having discussions with professors of UNAFEI.

Upon taking over the Viet Nam training programme from the International Cooperation Department of the Research and Training Institute of the Ministry of Justice in 2014, UNAFEI supports Viet Nam’s efforts to reform and improve its criminal justice system through conducting a series of programmes called the Joint Comparative Study on the Criminal Justice Systems of Japan and Viet Nam, as well as holding training courses for officers of Viet Nam’s Supreme People’s Procuracy.

In 2015, UNAFEI began providing technical assistance in the field of prison reform in Myanmar with the UNODC. The project is focused on the capacity-building of prison officers in Myanmar, and will be conducted through a series of seminars and training courses in Myanmar and Japan.

UNAFEI supports the third-country group training programme for effective community-based treatment of offenders in the CLMV countries (Cambodia, Lao PDR, Myanmar, Viet Nam) hosted by Ministry of Justice of Thailand.

## Regional Seminar on Good Governance for Southeast Asian Countries

UNAFEI, determined to contribute to the promotion of good governance in Southeast Asian countries, now holds an annual regional seminar commonly known as the GG Seminar. The aim of the Seminar is to reinforce the efforts made by Southeast Asian countries to establish the rule of law and good governance, and to assist in developing human resources.

The first two Seminars were held in Bangkok in partnership with the Office of the Attorney General of the Kingdom of Thailand and the UNODC. The third and fourth Seminars were held in Manila in partnership with the Department of Justice of the Republic of the Philippines. The fifth and sixth Seminars were held in Tokyo, Japan. The seventh and eighth Seminars were held in Kuala Lumpur in partnership with the Malaysian Anti-Corruption Commission (“MACC”). The ninth and tenth seminars were held in Indonesia (ninth in Jakarta, tenth in Yogyakarta) in partnership with the Attorney General’s Office of the Republic of Indonesia (“AGO”) and the Corruption Eradication Commission (“KPK”). Every year, officials from Southeast Asian countries attend the Seminar.

# UNAFEI cooperates with UN activities

## Contribution to the UN Congress and the UN Commission

UNAFEI attends the United Nations Commission on Crime Prevention and Criminal Justice (a functional commission of the UN Economic and Social Council, hereinafter called “the Commission”) held every spring in Vienna, Austria, and reports the outcomes of its activities, surveys and research to the Commission. In addition, UNAFEI contributes to the UN by making various suggestions for the planning and implementation of the UN Crime Prevention and Criminal Justice Programme.

UNAFEI has also taken an active part in the United Nations Congress on Crime Prevention and Criminal Justice (held every five years, hereinafter called “the Congress”), including the coordination and planning of workshops. At the 11th Congress held in Thailand in 2005, UNAFEI coordinated a workshop on the topic of “Measures to Combat Economic Crime, including Money Laundering.” UNAFEI also coordinated a workshop on “Strategies and Best Practices against Overcrowding in Correctional Facilities” at the 12th Congress, held in Brazil in 2010. At the 13th Congress held in Qatar in 2015, UNAFEI helped coordinate a workshop on the treatment of women offenders and children in conflict with the law. At the conclusion of the 13th Congress, it was announced that Japan would host the 14th Congress in 2020. UNAFEI will play an active role in the planning and operation of workshops held during the 14th Congress.

# Daily life at UNAFEI and an overview of the facilities

The participants usually stay in the dormitory attached to UNAFEI's main building. The living environment and meals are designed to meet the individual needs of the participants so that their stay will be as comfortable as possible. In their free time, they can enjoy activities such as billiards and table tennis, working out in our multigym, watching videos, singing karaoke, and dancing.

UNAFEI is fully equipped with facilities for residential training, including: an international conference hall with 56 seats in which three-language simultaneous interpretation is possible; an auditorium; and a library, where about 40,000 books and materials as well as computers connected to the Internet are available 24 hours a day. In the dormitory, there are 35 private rooms for the participants, as well as a lounge with a Japanese *tatami* room which provides a relaxed atmosphere. There are also accommodations and facilities for visiting experts.

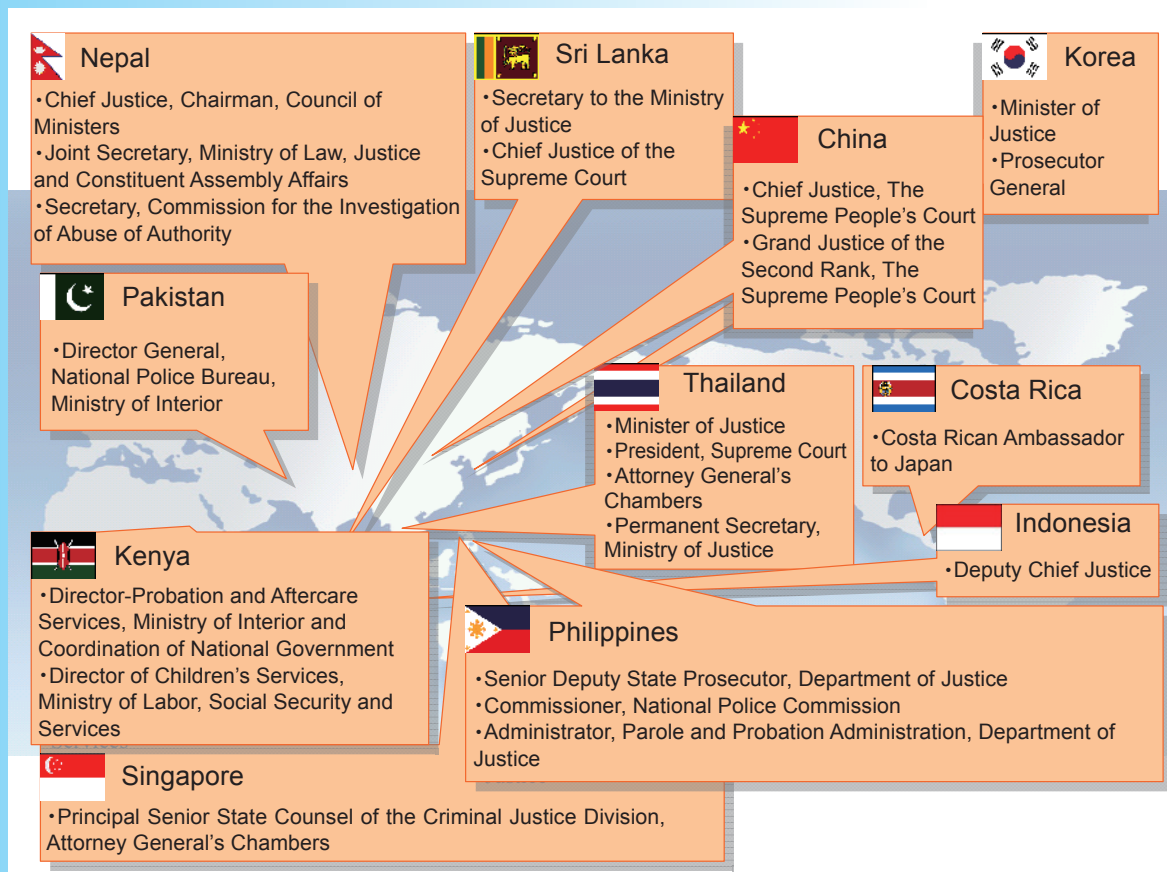
## More than 50 years' development of personal relationships has helped to establish a strong professional network

Over the past 50 years, more than 5,400 people from 137 countries/regions have participated in training courses and seminars organized by UNAFEI. Many UNAFEI alumni are playing leading roles in the area of criminal justice in their respective countries, and have a strong network of connections.

Crime today often extends beyond national borders; therefore networking among criminal justice agencies is an effective and valuable way of gathering information and facilitating international cooperation. In order to strengthen these connections, UNAFEI published a contact list containing the names of about 3,400 UNAFEI alumni and visiting experts in 2003, and sends e-mail newsletters to past participants to provide up-to-date information about UNAFEI's activities.

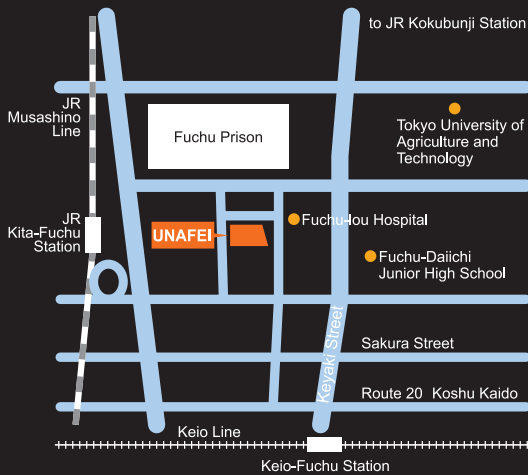
