2. Programme Overview

Trafficking in persons is a heinous crime that grievously harms its victims. Every year, hundreds of thousands of men, women, and children are trafficked and subjected to sexual exploitation, forced labour, slavery or other forms of exploitation. Many of them are exposed to multiple and chronic traumatizing events such as restriction of movement, direct physical violence, and verbal and psychological abuse, causing a number of physical and mental health problems that are difficult to recover from.

The objective of this Course was to offer participants an opportunity to share experiences, gain knowledge, and examine measures against trafficking in persons. In order to achieve this purpose, the Course programme provided an opportunity to examine the current situations and problems existing in the participants' respective countries.

Major topics for discussion included:

- O The actual situation of trafficking in persons;
- Measures for prosecution;
- Measures for protection of victims; and
- Measures for prevention.
