Introduction of lecturers

Mr. Steve Pitts, Ambassador, Confederation of European Probation



Mr. Pitts started his career as a probation officer in London and worked for the Prison and Probation Services of England and Wales, specialising in evidence-based practice, reintegration, community partnerships, and leading the Services' international work.

He worked as a consultant and advisor with the United Nations Office on Drugs and Crime and Council of Europe, supporting the development of probation services internationally, and devised, developed and realized the World Congress on Probation and Parole.

He is now Ambassador of the Confederation of European Probation and leads the international knowledge exchange and the development of effective and sustainable community justice.

Mr. Charlie Taylor, His Majesty's Chief Inspector of Prisons

Mr. Taylor taught for many years in both primary and secondary schools in London. He began to specialise in supporting pupils with special educational needs and in 2005 became the headteacher of the Willows Special School (now The Willows School Academy Trust) for children with severe emotional and behavioural difficulties.

In 2011 he became an expert adviser on children's behaviour at the Department for Education, and in 2012 he became the CEO of the National College for Teaching and Leadership.

He led the 2015 review into the youth justice system and made wide-ranging recommendations, including a new model for youth custody. In 2017 he became Chair of the Youth Justice Board and continued working with the Department for Education to improve the ability of schools to support their most challenging pupils.

He was initially appointed as HM Chief Inspector of Prisons in 2020 and was reappointed in 2023.
