## **MAIN ACTIVITIES OF UNAFEI (1 January 2022 – 31 December 2022)**

### **I. ROLE AND MANDATE**

The Asia and Far East Institute for the Prevention of Crime and the Treatment of Offenders (UNAFEI) was established in Tokyo, Japan, in 1962 pursuant to an agreement between the United Nations and the Government of Japan. Its goal is to contribute to sound social development in the Asia and the Pacific region by promoting regional cooperation in the field of crime prevention and criminal justice, through training and research.

UNAFEI has paid utmost attention to the priority themes identified by the Commission on Crime Prevention and Criminal Justice. Moreover, UNAFEI has been taking up urgent, contemporary problems in the administration of criminal justice in the region, especially problems generated by rapid socio-economic change (e.g., transnational organized crime, corruption, economic and computer crime and the reintegration of prisoners into society) as the main themes and topics for its training courses, seminars and research projects.

### **II. TRAINING**

Training is the principal area and priority of the Institute's work programmes. In the international training courses and seminars, participants from different areas of the criminal justice field discuss and study pressing problems of criminal justice administration from various perspectives. They deepen their understanding, with the help of lectures and advice from the UNAFEI faculty, visiting experts and ad hoc lecturers. This so-called "problem-solving through an integrated approach" is one of the chief characteristics of UNAFEI programmes.

Each year, UNAFEI conducts two international training courses and one international seminar. Approximately one hundred government officials from various overseas countries receive fellowships from the Japan International Cooperation Agency (JICA is an independent administrative institution for ODA programmes) each year to participate in all UNAFEI training programmes.

Training courses and seminars are attended by both overseas and Japanese participants. Overseas participants come not only from the Asia-Pacific region but also from the Middle and Near East, Latin America and Africa. These participants are experienced practitioners and administrators holding relatively senior positions in the criminal justice field.

By the end of 2022, UNAFEI had conducted a total of 179 international training courses and seminars. Over 6,300 criminal justice personnel representing 142 different countries and administrative regions have participated in these seminars. UNAFEI also conducts a number of other specialized courses, both country and subject focused, in which hundreds of other participants from many countries have been involved. In their respective countries, UNAFEI alumni have been playing leading roles and hold important posts in the fields of crime prevention and the treatment of offenders, and in related organizations.

**A. The 177th International Senior Seminar**

1. Theme, Duration and Participants

- “Preventing Reoffending through a Multi-stakeholder Approach”
- From 12 January to 3 February 2022
- 19 overseas participants from 12 jurisdictions

2. Programme Overview

As stipulated in the Kyoto Declaration, preventing reoffending through a multi-stakeholder approach is an important theme in the criminal justice field internationally. This seminar aims to promote these efforts in participating countries, by sharing experiences and discussing (i) case disposition and penalties with due regard to rehabilitative perspectives and (ii) tailoring intervention, treatment and support to individual needs by effectively incorporating inter-agency cooperation and public-private partnerships. This programme was exclusively conducted online due to the Covid-19 pandemic.

3. The Content of the Programme

(1) Lectures and other presentations

The participants were from a wide range of time zones, including Asia, Africa and Latin America, and they needed to continue their professional and family duties during the seminar. Therefore, all lectures were recorded in advance and broadcast on-demand in order to allow participants to view lectures at their convenience. After watching the on-demand lectures, participants were required to submit questions or comments via an online learning management system, and their questions were answered in Q&A live sessions with the respective lecturers. This way, we tried to ensure both convenience and interactivity in lectures.

The lectures were firstly delivered by UNAFEI professors on the criminal justice system in Japan, as well as on specific topics relating to this seminar such as promoting measures for reducing reoffending, non-custodial sentences, assessment and re-entry support. After that, the specialist lectures and ad hoc lecturers were delivered, followed by Q&A sessions. Furthermore, as a special session, eight Japanese volunteer probation officers were invited to share their experience as community volunteers.

## (2) Group Workshops

Participants were divided into four groups considering their time zones, Individual Presentations topics and professional backgrounds.

### ➤ Individual Presentations

Participants shared the practices and the challenges in their respective countries regarding the theme of the seminar through their individual presentations. All the presentations were recorded and uploaded online so that participants in other groups could watch them afterwards.

### ➤ Discussions

Built on the knowledge gained through lectures and individual presentations, the participants engaged in live discussions to explore more about the theme of the seminar. The subtopics discussed were: (i) Imposition of penalties and case dispositions with due regard to rehabilitative perspectives and (ii) Interventions, treatment and support tailored to offenders’ individual needs, with sufficient consideration of a multi-stakeholder approach. Participants shared challenges and good practices in their respective countries with group members, and discussed the root causes and necessary actions for common challenges.

An overview of the discussions is as follows:

- *Imposition of penalties and case dispositions with due regard to rehabilitative perspectives*  
Although it is necessary to ensure due process and proportionality in imposing penalties and case dispositions, the participants reaffirmed the importance of effective use of non-custodial measures as far as possible since they can avoid the negative impact of imprisonment on rehabilitation of offenders and facilitate their social reintegration. They shared the legal basis for non-custodial measures, including the applicable options, criteria, discretionary power given to judges, prosecutors etc. It was reported that the existence of laws that provide non-custodial options does not necessarily mean they are fully used in practice. Many factors that would affect the active use of non-custodial measures were discussed, such as the necessity of sentencing guidelines, appropriate assessment required for appropriate use of non-custodial measures, the authority to implement non-custodial sentence in the community and collaboration with community partners who can support offenders. It was also noted that efforts should be made for providing adequate capacity-building and promoting understanding for rehabilitation of offenders among judiciary and law enforcement officers.

- *Interventions, treatment and support tailored to offenders' individual needs*  
To make interventions, treatment and support for offenders most effective, participants recognized the importance of assessment throughout the criminal justice process to identify the individual needs of offenders. Various socio-economic factors relating to crime, such as poverty, isolation, association with gangs and other forms of organized crime, etc. were considered. Participants stressed the importance of support for employment, education and various support in collaboration with stakeholders to reintegrate offenders into the community, but various challenges which hamper rehabilitation and social reintegration of offenders were also discussed. In prisons, for example, overcrowding was indicated as a significant factor that impedes rehabilitative environments that would facilitate offender treatment, while in the community, lack of monitoring or supporting systems for released offenders, as well as resources to fulfil them, were discussed. Furthermore, many participants regarded the issue of general perceptions of offenders as critically important, since prevailing punitive attitudes would make it difficult to engage various stakeholders in supporting offender rehabilitation. Therefore, government initiatives not only for promoting inter-agency coordination and community engagement in supporting offender rehabilitation but also for raising awareness of the importance of offender rehabilitation were emphasized.

#### 4. Feedback from the Participants

At the end of the seminar, we invited feedback from all participants. They said that, even though conducted online, they learned a lot from lectures and group discussions, and many of them indicated that the seminar served as an opportunity to reaffirm the importance of incorporating rehabilitative perspectives and multi-stakeholder approaches in their respective professional areas. They also indicated that, if it were conducted in person, they would learn more about the Japanese system and practice by visiting relevant institutions in Japan.

#### 5. Comments from the Programming Officer

This seminar discussed the theme of preventing reoffending. In order to reduce reoffending, a wide range of individual and social factors which would induce or deter crime should be addressed. It cannot be achieved only by efforts of penal institutions. It requires active involvement of relevant agencies with various expertise, as well as various community resources.

In order to ensure that the “multi-stakeholder approach” is not just empty words, key persons are required to make a difference in their systems and practices. The participants in this seminar fully understood the concept of the theme and were highly motivated to learn from the experiences of other countries and lectures. They showed great discernment in analysing their current systems and practices, and they recognized the need to review their systems and practices from the viewpoint of offender rehabilitation, with due attention to society and human rights. I believe such sincere attitudes towards learning stimulated their discussions, and I learned a lot from the participants.

The International Senior Seminar invites high-ranking policymakers and practitioners, and it provides them with a great opportunity to learn deeply about important themes in criminal justice. I hope that the knowledge, thoughts and new perspectives on reducing reoffending gained in this 177th seminar will be gradually disseminated to various

stakeholders in their respective countries, leading toward a global society in which “no one will be left behind” as envisaged in the SDGs.

## **B. The 178th International Training Course**

### 1. Theme, Duration and Participants

- “Cybercrime and Digital Evidence”
- From 14 June to 7 July 2022
- 29 overseas participants from 14 jurisdictions

### 2. Programme Overview

Criminals abuse newest cyber technologies and leave digital footprints at all stages of their activities. Digital evidence crosses borders so easily that investigation and prosecution have become even more challenging. This programme provided criminal justice authorities with knowledge and expertise to tackle all crimes that involve digital evidence. Particular focus was placed on (1) finding, preserving, collecting, analysing and utilizing digital evidence and (2) international cooperation regarding investigation of cybercrime and all other crimes that involve digital evidence. This programme was exclusively conducted online due to the Covid-19 pandemic.

### 3. The Content of the Programme

#### (1) Lectures

Since the participants needed to continue their professional and family duties during the programme, the lectures were recorded in advance and broadcast on-demand for their convenience, followed by live Q & A sessions with the lecturers. UNAFEI faculty members gave on-demand lectures on the “Criminal Justice System in Japan”, “The overview of Rules of Evidence in Japan” and “Legal Developments Related to Digital Evidence in Japan”. (2) Group Work

Participants were divided into four groups based on time zones and the themes of their choice for the Individual Presentations sessions and discussions.

➤ Individual Presentations

Participants shared the practices and the challenges in their respective jurisdictions regarding the theme of the Programme through their individual presentations. All the presentations were recorded and uploaded online for reference by participants in other groups or those who could not attend the sessions.

➤ Discussions

Participants had fruitful discussions on the themes of the Programme: (i) finding, preserving, collecting, analysing and utilizing digital evidence and (ii) international cooperation regarding investigation of cybercrime and all other crimes that involve digital evidence.

- Finding, preserving, collecting, analysing and utilizing digital evidence  
First, common issues mainly discussed were “capacity building of criminal justice practitioners dealing with digital evidence”, considering that there were differences in the legal systems and procedures for the handing of digital evidence in each country. The participants, based on the actual situation in their respective countries, exchanged opinions on the “necessity of acquiring specialized knowledge” and “enhancement of digital forensic technology and equipment”. Proposals were made regarding the need for public relations and awareness-raising activities as part of measures against cybercrime, and many pointed out the importance of public-private partnerships for that purpose.
  
- International cooperation regarding investigation of cybercrime and all other crimes that involve digital evidence  
Regarding international cooperation, the general issues are the delay in responding to requests for mutual legal assistance in investigations, the complexity of procedures, and the small number of member countries of the Budapest Convention. As measures to promote international cooperation, the participants were in favour of promoting informal information exchanges, recognizing the necessity of collecting and analysing digital evidence in collaboration with law enforcement agencies in other countries.

### (3) Action Plans

Each group concluded the programme by presenting their own action plans based on the challenges they identified and what they learned in the lectures, presentations by the colleagues and discussions.

#### 4. Feedback from the Participants

Almost all participants commented that they would have preferred face-to-face training in Japan; however, various lectures and discussions were enriched and informative knowledge and practices were exchanged during the online course.

#### 5. Comments from the Programming Officer

The theme of “Cybercrime and Digital Evidence” is an issue that all countries are interested in, and I felt the enthusiasm of each participant in the course. Information and communication technology is advancing day by day, and new types of cybercrime are appearing one after another. In this regard, effective countermeasures against them have become an urgent issue in each country. For this reason, as each lecture contained cutting-edge knowledge and practical experiences, including contents that were difficult for participants to obtain in their own countries, the participants were highly interested, which led to active discussions. We hope that the knowledge gained from this course will be utilized in the development and enhancement of each participant’s jurisdiction.

### C. **The 179th International Training Course**

#### 1. Theme, Duration and Participants

- “Juvenile Justice and Beyond – Effective Measures for the Rehabilitation of Juveniles in Conflict with the Law and Young Adult Offenders”
- From 6 to 29 September 2022
- 24 overseas participants from 16 countries

#### 2. Programme Overview

Juveniles are socially and psychologically immature, and they are susceptible to stress and trauma. On the other hand, juveniles are often more responsive to efforts at rehabilitation and reintegration with appropriate intervention and support. Hence, it is important for correctional services to promote well-being and personal development by providing appropriate measures and treatment, making use of the formative period. In addition, this approach should also be extended to young adult offenders because cognitive function changes gradually; consequently, young adults are similar to juveniles in many respects.

In light of the above, this programme provided opportunities to share each country's practices and discuss effective institutional and community-based treatment and juvenile justice systems for juveniles in conflict with the law and young adult offenders.

#### 3. Method of Training

This programme was exclusively conducted online due to the Covid-19 pandemic. In consideration of time differences between countries, the programme was conducted in two groups. Since the participants needed to continue their professional and family duties during the programme, some lectures were recorded in advance and broadcast on-demand for their convenience, followed by live Q & A sessions with the lecturers.

(4) Individual Presentations

Participants shared the practices and the challenges in their respective jurisdictions regarding the theme of the programme through their individual presentations. All the presentations were recorded and uploaded online for reference by participants in the other group.

(5) Group Workshops (Case Study)

Participants were divided into four groups according to time zones. The participants discussed a fictional case of a juvenile offender and explored appropriate measures and

treatment for the juvenile based on risk assessment and best practices for rehabilitation and reintegration, which are the main topics of this training programme.

A 16-year-old male juvenile in the fictional case faced multiple problems in his family and educational environment and, consequently, he assaulted his colleague. Based on the facts of the case, the following three topics were discussed: (i) assessment of the juvenile's risk of reoffending, (ii) treatment, education and vocational training necessary for the juvenile, and (iii) improvement of the relationship between the juvenile and his family and support for his family. The results of the discussion were presented by each group.

Assessment of offenders is effective in measuring the risk of reoffending as well as in improving the treatment of offenders. In this programme, there were several explanations on the importance of the risk assessment, and each group discussed the risk of the juvenile in the fictional case, referring to their knowledge gained from the lectures. The participants constructively discussed and developed best practices for each group although the systems and practices differ from country to country.

#### (6) Action Plans

At the end of the programme, each participant presented an Action Plan based on the abovementioned lectures, individual presentations and group workshops. They identified the challenges in their countries and proposed possible solutions based on what they learned from the lectures, presentations by the other participants and discussions in the group workshops. It was obvious from the Action Plans presented by the participants that everyone remarkably enhanced their understanding on juvenile justice and related issues and was eager to put their plans into practice in their countries.

#### 5. Feedback from the Participants

We received a lot of positive feedback from the participants. They commented that all the lectures, group workshops and interactions with lecturers and participants were very useful. Relevant materials provided prior to and during the programme (UN documents, research articles, publications and videos) were also highly evaluated. Several participants commented that observation visits to facilities and agencies in Japan would have contributed to enhance their understanding further.

#### 6. Comments from the Programming Officer

In light of the plasticity of juveniles and young adults, the timely and appropriate intervention to help and protect juveniles in conflict with the law and young adult offenders is a critical issue for the entire world. In addition, as a problem that has emerged through lectures and the group workshops, it is also necessary to provide support to their families and to include the whole community in taking comprehensive approaches. This is because the sound development of juveniles and young people is hindered by inappropriate environments, poverty, and organized crime and violent extremism.

Throughout the training period, the participants enthusiastically and actively participated in all the sessions. The final Action Plans were creative presentations from a wide viewpoint such as approaches to the local community and the importance of capacity-building of staff. All the presentations were very meaningful and substantial. I am sure that the participants will make the most of what they have learned from the programme. Despite the inability to meet in person, it was worth providing the opportunity to learn from each other online.

### **III. SPECIAL TRAINING COURSES, TECHNICAL ASSISTANCE AND OTHER ACTIVITIES**

#### **A. The Online Training for the Parole and Probation Administration in the Philippines**

From 19 January to 11 May 2022, UNAFEI, in collaboration with the United Nations Office on Drugs and Crime (UNODC) and other experts, conducted an online training course once a week for 16 sessions on the subject of principles of effective parole and probation.

#### **B. Training for Timor-Leste on Prison Reform**

On 27 January 2022, 13 officials from the National Directorate of Prison Services and Social Reintegration and prison staff from Timor-Leste participated in an online training course on the theme of “Development of assessment tools”. The course was held by UNAFEI and the UNODC.

#### **C. The Online Seminar for Officials in Kenya**

From 7 to 10 February 2022, UNAFEI conducted an online training seminar for Kenyan officials involved in juvenile justice.

#### **D. Exchange Programme between the Japanese Prosecution Service and the Supreme People's Procuracy of Viet Nam**

On 18 February 2022, the Exchange Programme between the Japanese Prosecution Service and the Supreme People's Procuracy of Viet Nam was held, and 48 Vietnamese criminal justice practitioners discussed and exchanged views under the theme of “Judicial Reform”.

#### **E. Francophone African Criminal Justice Seminar FY2021 (Online)**

From 22 to 25 February 2022, UNAFEI, in collaboration with JICA, held an online training seminar in which 16 participants from 4 Francophone African countries participated and discussed challenges and solutions on digital evidence.

#### **F. The Comparative Study on Criminal Justice Systems of Japan and Nepal (Online)**

From 28 February to 4 March 2022, 12 Nepalese criminal justice practitioners discussed challenges to the implementation of the new Criminal Procedure Code in Nepal.

#### **G. The First International Training Course on Building Inclusive Societies (Online)**

From 2 to 17 March 2022, UNAFEI held an online training course on the theme of “Protection of the Rights of Crime Victims including Children”. 13 participants from 8 jurisdictions attended.

#### **H. The Second Youth International Training Course (Online)**

From 1 to 5 August 2022, 24 youth participants from Japan and overseas participated in an online training course on the theme of “Towards a Society without Child Abuse: Seeking Youth-led Solutions”.

#### **I. The Study Tour for Cambodian Officials on Community-based Treatment**

From 23 to 31 August 2022, in collaboration with the UNODC, UNAFEI invited 14 government officials from the Kingdom of Cambodia to UNAFEI for a study tour on the community-based treatment of offenders, specifically focusing on the parole system.

**J. The 24th UNAFEI UNCAC Training Programme**

From 2 to 28 November 2022, 30 overseas criminal justice practitioners from 21 jurisdictions and 2 Japanese participants discussed the theme of “Identifying, Tracing, Freezing, Seizing, Confiscating and Recovering Proceeds of Corruption: Challenges and Solutions”.

**K. The Sixteenth Regional Seminar on Good Governance for Southeast Asian Countries**

From 14 to 16 December 2022, UNAFEI held the Sixteenth Regional Seminar on Good Governance at UNAFEI in Tokyo, Japan. The theme of the seminar was “New and Emerging Forms of Corruption and the Effective Countermeasures”. 17 anti-corruption practitioners from the ASEAN member countries plus Timor-Leste participated.

**V. INFORMATION AND DOCUMENTATION SERVICES**

The Institute continues to collect data and other resource materials on crime trends, crime prevention strategies and the treatment of offenders from Asia, the Pacific, Africa, Europe and the Americas, and makes use of this information in its training courses and seminars. The Information and Library Service of the Institute has been providing, upon request, materials and information to United Nations agencies, governmental organizations, research institutes and researchers, both domestic and foreign.

**VI. PUBLICATIONS**

**A. Annual Publications**

Reports on training courses and seminars are published regularly by the Institute. Since 1971, the Institute has issued the Resource Material Series, which contains contributions by the faculty members, visiting experts and participants of UNAFEI courses and seminars. In 2022, the 113rd and 114th editions of the Resource Material Series were published. Additionally, issues 163 through 166 (from the 176th International Training Course to the 179th International Training Course, respectively) of the UNAFEI Newsletter were published, which included brief reports on UNAFEI’s training courses and seminars and other timely information. **B. Research Studies by UNAFEI Professors**

UNAFEI’s main work is to conduct international training courses and seminars for personnel in crime prevention and criminal justice administration in developing countries around the world, as well as regional and bilateral support and research on crime prevention and treatment of offenders. Through long-term international training and regional and bilateral support, UNAFEI has accumulated knowledge on criminal justice in various countries, mainly in the participating countries.

Based on this knowledge, we have published “Prevention of Crime and Treatment of Offenders”, known as UNAFEI’s Resource Material Series, and other publications to introduce criminal justice systems in Japan and other Asian countries in the past.

## VII. OTHER ACTIVITIES

### A. Public Lecture Programme

On 8 February 2022, the Public Lecture Programme was conducted online due to the Covid-19 pandemic. Notably, the event marked the 40th anniversary of the lecture series. There were 357 participants from 41 countries and regions who attended. This Programme was jointly sponsored by the Asia Crime Prevention Foundation (ACPF), the Japan Criminal Policy Society (JCPS) and UNAFEI.

Public Lecture Programmes increase the public's awareness of criminal justice issues, through comparative international study, by inviting distinguished speakers from abroad. In 2022, Mr. Celso J.N. Manata, Deputy Attorney General of Portugal, and Professor Shadd Maruna, Professor of Criminology at Queen's University Belfast, Northern Ireland, were invited as speakers. They presented on "Prisoner's Rights and Courts" and "Lived Experience' Research in Criminology and Desistance from Crime", respectively.

### B. Event on Reducing Reoffending with PNI Experts

From 18 to 21 October 2022, we invited 12 experts (9 experts from 7 of the United Nations Crime Prevention and Criminal Justice Programme Network Institutes (PNI), together with 3 observers) to UNAFEI for an event on reducing reoffending. The main theme was "Enhancing Technical Assistance to Reduce Reoffending and Promote an Inclusive Society". The experts explored effective technical assistance for reducing reoffending in developing countries with limited human or material resources. Due to the Covid-19 pandemic, personal contact between the PNI had been restricted for several years, so on this occasion, we were very pleased to hold an in-person meeting to enhance the PNI network.

### C. UNAFEI's 60th Anniversary Event

We are very pleased to announce that UNAFEI held its 60th Anniversary event titled "Creating Inclusive Societies: Approaches to Reducing Reoffending" in a hybrid format (at the Ministry of Justice and online) on 21 October 2022. The audience was very much impressed by the insightful and inspiring lectures from the following three speakers:

Following the Event, the Joint Ceremony for UNAFEI's 60th and ACPF's 40th Anniversaries was held at ZCK Hall, Tokyo. Congratulatory speeches (including recorded speeches) were delivered by: His Excellency HANASHI Yasuhiro, Minister of Justice, the Honourable Judge Piotr Hofmański, President, International Criminal Court, and the Honourable Ms. Ghada Fathy Waly, Executive Director, United Nations Office on Drugs and Crime.

### D. Special Lecture by Dr. Kittipong Kittayarak

On 11 November 2022, UNAFEI, in collaboration with the Thailand Institute of Justice (TIJ) and ACPF, hosted the Special Lecture by Dr. Kittipong Kittayarak, special advisor to the TIJ. The theme of this Special Lecture was "Reimagining Justice in Thailand: Towards a

Collaborative and People Centered Approach”. About 100 participants gathered at the venue, and about 100 participants observed lecture online.

#### **E. Assisting UNAFEI Alumni Activities**

Various UNAFEI alumni associations in several countries have commenced, or are about to commence, research activities in their respective criminal justice fields. It is, therefore, one of the important tasks of UNAFEI to support these contributions to improve the crime situation internationally.

**G. Assisting ACPF Activities**

UNAFEI cooperates and collaborates with the ACPF to improve crime prevention and criminal justice administration in the region. Since UNAFEI and the ACPF have many similar goals, and a large part of the ACPF's membership consists of UNAFEI alumni, the relationship between the two is very strong.

**VII. HUMAN RESOURCES**

**A. Staff**

In 1970, the Government of Japan assumed full financial and administrative responsibility for running the Institute. The Director, Deputy Director and approximately nine professors are selected from among public prosecutors, the judiciary, corrections, probation and the police. UNAFEI also has approximately 15 administrative staff members, who are appointed from among officials of the Government of Japan, and a linguistic adviser. Moreover, the Ministry

of Justice invites visiting experts from abroad to each training course and seminar. The Institute has also received valuable assistance from various experts, volunteers and related agencies in conducting its training programmes.

## **VIII. FINANCES**

The Ministry of Justice primarily provides the Institute's budget. UNAFEI's total budget for its programmes is approximately ¥127 million per year. Additionally, JICA and the ACPF provide assistance for the Institute's international training courses and seminars.

## WORK PROGRAMME FOR 2023

### I. TRAINING

#### A. Training Courses & Seminars (Multinational)

1. The 180th International Senior Seminar

The 180th International Senior Seminar was held from 13 January to 6 February 2023. The main theme of the Seminar was “Promoting Legal Aid for Offenders and Victims”. Twenty-two overseas participants and three Japanese participants attended.

2. The Second International Training Course on Building Inclusive Societies

The Second International Training Course on Building Inclusive Societies was held from 8 to 20 March 2023. The main theme of the Course was “Rehabilitation and Social Reintegration of Offenders with Substance Use Disorders”. Fifteen overseas participants and two Japanese participants attended.

3. The 181st International Training Course

The 181st International Training Course was held from 12 May to 8 June 2023. The main theme of the Course was “Countermeasures against Transnational Organized Crime –The 20th Anniversary of UNTOC–”. Twenty-five overseas participants and three Japanese participants attended.

4. The 182nd International Training Course

The 182nd International Training Course was held from 8 September to 3 October 2023. The main theme of the Course was “Effective Support for Reintegration of Released Inmates – Toward Seamless Support for Employment, Housing and Medical Care”. Seventeen overseas participants and seven Japanese participants attended.

5. The 25th UNAFEI UNCAC Training Programme

UNAFEI’s annual general anti-corruption programme, the UNAFEI UNCAC Training Programme, was held from 2 to 28 November 2023. The main theme of the Seminar was “Effective Corruption Investigation Utilizing International Cooperation”. Thirty overseas participants and four Japanese participants attended.

6. The Seventeenth Regional Seminar on Good Governance for Southeast Asian Countries

From 13 to 15 December 2023, UNAFEI held the Seventeenth Regional Seminar on Good Governance for Southeast Asian Countries in Tokyo, Japan. The main theme of the Seminar was “Protecting Judges, Prosecutors and Law Enforcement Officials from Undue Interference Including Bribery”.

#### B. Training Course (Country Specific)

1. The Study Tour for Kenyan Officials in Japan

From 9 to 14 February 2023, UNAFEI invited 9 government officials from Kenya for a study tour on the community-based rehabilitation of children in conflict with law.

2. The RTI-SPP Exchange Programme for Viet Nam

From 15 to 17 February, two Vietnamese participants discussed the judicial Reform.

3. The Francophone African Criminal Justice Seminar FY 2022

The Francophone African Criminal Justice Seminar FY 2022 was held from 28 February to 10 March 2023 at JICA Tokyo. The theme of the Seminar was “Challenges in Investigation and Trials of Drug Crimes and Measures to Tackle These Challenges”. Twenty-six participants from seven Francophone African countries participated.

4. The 10th Comparative Study on the Criminal Justice Systems of Japan and Nepal

From 20 to 26 July 2023, twelve Nepalese participants attended to analyse the issues from a comparative point of view and improve the practice of the criminal justice system in Nepal under the new Criminal Procedure Code.
